

**TERMS AND CONDITIONS  
OF  
SPORT SINGAPORE'S  
ACTIVESG SPORT INTEREST GROUPS**

**BY PARTICIPATING IN ACTIVESG SPORT INTEREST GROUPS, YOU HEREBY CONFIRM THAT YOU HAVE READ, UNDERSTOOD AND AGREED TO BE BOUND BY THE FOLLOWING TERMS AND CONDITIONS.**

**1. The Organiser**

- 1.1 The **ActiveSG Sport Interest Groups** (the “**Programme**”) is organized by the Singapore Sports Council (rebranded as “Sport Singapore” with effect from 1 April 2014 and hereinafter referred to as “**SportSG**”) of 3 Stadium Drive, Singapore 397630.

**2. Eligibility**

- 2.1 The Programme is open to everyone registered with ActiveSG.  
2.2 For participants aged below 18 years, it is mandatory to obtain the consent of your parent/guardian before participating in this Programme.

**3. Commencement**

- 3.1 The Programme shall run from 1 February 2024, 0000 hrs onwards, until determined by SportSG.

**4. Programme Requirements/Criteria**

- 4.1 Participants must adhere to all relevant laws, rules and regulations, and all of SportSG’s guidelines and rules and regulations when taking part in the Programme.  
4.2 Subject to Clause 4.3, the following fees apply to the Programme:

- 4.3 The fees set out above are correct at the time of printing. Please refer to our ActiveSG circle page - [Active Interest Group \(activesgcircle.gov.sg\)](https://activesgcircle.gov.sg) for the latest programme registration fees

and registration details. These shall form part of these terms and conditions governing the Programme.

- 4.4 Payment & registration must be completed before commencement of play.
- 4.5 Registration fees are strictly non-refundable.
- 4.6 ActiveSG credits cannot be used for this Programme.
- 4.7 No refund will be made following commencement of the first session of the Program.
- 4.8 Group sizes for each sport are as follows:

Sport	Group size per court
Badminton/Pickleball/Tennis	Max 8 persons (min. of 6 persons required to start a group)
Table Tennis/Squash/TTX	Max 5 persons (min. of 4 persons required to start a group)
Basketball & Volleyball	Max 20 person (min. of 12 persons required to start a group)

The above shall be subject to any prevailing safety regulations. SportSG reserves the right to allocate the number of persons to each court.

- 4.9 No replacement of member(s) is allowed.
- 4.10 Proof of identity/receipt must be produced for verification at each session.
- 4.11 All members of group are to uphold fairness of play.
- 4.12 Participants are to bring their own sport equipment. Should a participant require table tennis equipment, he/she shall request for the equipment from guest service reception at the respective ActiveSG sport centre, and return the equipment after the session. The participant shall take care to ensure that the equipment is not damaged during his/her usage. In the event that damage is caused during the session, the participant may be required to pay for any and all costs related to any repair or replacement of such damaged equipment.
- 4.13 Schedules of play might be subject to change due to venue availability.
- 4.14 SportSG reserves the right to amend these Terms and Conditions without any prior notice.

## **5. Participant's warranties and undertakings**

- 5.1 By participating you represent, warrant, undertake, agree and/or acknowledge that:
  - a. you have read and understood, and thereby agree to these Terms and Conditions, including all amendments, additions, replacements and modifications hereto as may from time to time be made by SportSG.
  - b. If you are under the age of 18, you have obtained the consent of your parent and/or guardian to participate in the Programme. Any references to consent in this terms and conditions shall refer to consent from your parent/guardian if you are under the age of 18.

## **6. Miscellaneous**

### *Personal Details*

- 6.1 All personal details (and that of your parent/guardian if you are below 18) collected for registration purposes will be managed in accordance with our Privacy Policy which can be found here at <https://www.myactivesg.com/privacy>.

### *Registration*

- 6.2 SportSG reserves the right to disqualify and remove you from the Programme as it deems fit and its decision in this regard shall be absolute and final and no appeals will be entertained.
- 6.3 SportSG shall not be liable for any incomplete, lost, late, damaged, illegible and/or misdirected registration entries for any reason whatsoever and/or problems and/or technical malfunction of any telephone network and/or lines, computer online systems, servers, and/or providers, computer equipment, software, technical problems and/or traffic congestion on the internet and/or at any website, and/or any combination thereof, and/or any injury and/or damage to your and/or any other person's computer related to and/or resulting from registration in the Programme. SportSG shall not entertain nor be liable for any claims whatsoever in respect of whether a particular registration entry from you was duly received and/or accepted for participation in the Programme.
- 6.4 SportSG further reserves the right to declare any registration void and/or to modify the Programme or any part thereof and/or to cancel the entire Programme at any time at its sole and absolute discretion.

### *Liability and Indemnity*

- 6.5 You (including your heirs, executor and/or administrators, parents and/or guardians (if you under 18 years of age)) hereby agree to indemnify fully and hold SportSG and its directors, officers, employees, and assignees (the "**Indemnified Parties**") harmless from and against any and all claims, losses, liability and/or damages (including but not limited to economic loss, damage to any property and/or injury to and/or death of any person and any legal costs) that may be suffered or incurred by any of the Indemnified Parties arising whether directly or indirectly from the Programme including:
  - a. Any negligent act, omission and/or wilful default, misconduct or fraud by you; or
  - b. any action, claim, loss, damage, cost and expense whatsoever brought against, suffered or incurred arising from or in connection with any breach of the terms and conditions hereunder (including, without limitation to the generality of the foregoing, a breach of the representations, warranties, undertakings, agreements or acknowledgements hereof) by you.
- 6.6 Neither SportSG nor SportSG's employees, affiliates, representative offices, authorized agencies associated with the Programme shall be held liable for any failure and/or omission to carry out the Programme in accordance with these terms and conditions and/or for any loss and/or damage suffered by you in relation to the Programme and/or your participation therein, including where such failure, omission, loss and/or damage arises out of or in connection with any event of force majeure, including without limitation any calamity and/or conditions, Acts of God, war or warlike hostilities, civil commotion, riots, blockades, embargoes, sabotages, strikes, fires, lockouts, shortages of material or labour, terrorist activity, epidemic, quarantine restrictions, health risk and/or any defect, failure, and/or any other occurrence beyond the reasonable control of SportSG, SportSG's employees, affiliates, representative offices, authorized agencies and/or any sponsor associated with the Programme, as the case may be.

- 6.8 The Programme and these terms and conditions shall be governed by and construed in accordance with the laws of Singapore, and by participating, you submit to the exclusive jurisdiction of the Courts of the Republic of Singapore.
