

#### **General Information**

- SwimSafer CAMS Platform <u>HTTPS://SAQSWIMSG.ORG.SG</u>
- All participants must create an account on the CAMS Platform to register for SwimSafer assessments..
- Personal information can be edited in the "My Profile" section of your account once created.

## **Registration & Payment**

- Closing deadline Exactly 3-weeks before the assessment date and time. (e.g. assessment on 21 September 11:30am closes on 31 August 11:30am)
- Validation Registrations made by participants/parents must be validated before the registration closing deadline by the recognised SwimSafer coach tagged to the participant.
- Payment Payment for assessment *must be completed in the CAMS*Platform before the registration closing deadline in order to complete the registration.
  - 1. Log into the CAMS Platform
  - 2. Go to "My Cart"
  - 3. Complete payment before the closing deadline

## **Online Theory Quiz**

- The online theory quiz must be completed on the CAMS Platform and is available upon successful registration for the practical assessment.
- To complete the online theory quiz:
  - 1. Log into the CAMS Platform
  - 2. Click on the "My Quizzes" tab.
  - 3. Click on the relevant quiz to begin.

- There is no limit on the number of attempts a participant may have for the relevant online theory quiz. Participants will pass by achieving a result of 90% or higher.
- Participants must complete the online theory quiz within seven (7) days after the designated practical assessment (eg. Practical assessment date 21 September; participants will have up to 28th September to pass the online theory quiz).

## Rescheduling

- After completing your registration, you may reschedule your assessment as long as it is made before the registration closing deadline.
- The rescheduled assessment which has been booked must be completed within six (6) months of the original date.





## **Assessment Day**

- Parental Consent Form Submit prior to the assessment using the following link (<a href="https://go.gov.sg/ssconsent">https://go.gov.sg/ssconsent</a>). Parents must present the email confirmation of the submitted consent form at the registration counter.
- Registration Counter Opens 30mins before the scheduled assessment time. Please arrive early. Arriving late for the assessment session will result in being declined for the assessment.
- Please remember to bring any equipment for the test, as necessary: (example)
  - Goggles
  - T-shirt and shorts for stages 1-4
  - T-shirt and long pants for stage 5 & 6

(Note that incorrect venue attendance, or not having the above stated equipment of goggles, t-shirt and shorts or long pants, would result in the participant being declined from being allowed to participate of the assessment)

- Inclement Weather Assessments that are cancelled due to inclement weather shall be eligible for a rescheduled assessment.
- Medical Participants who are absent with a valid medical reason shall be eligible for a rescheduled assessment. A copy of the medical Certificate must be sent to:

#### **Results & Certificates**

- **Results -** Available within 48 hours; accessible on the CAMS Platform under "My Results".
- Appeals Must be submitted via the CAMS Platform within 72 hours after the release of the assessment results
- **Certificates** Certificates achieved from July 2025 retrieved on the CAMS Platform. Available upon completion of both the practical assessment and online theory quiz for the relevant stage. MyActiveSG+ is not part of the theory quiz system.
- Old Certificates Certificates achieved before July 2025 will currently still be retrieved from FileSG through ActiveSG SwimSafer.

## Illustrative Example A – Timeline for registration, payment and online theory quiz

#### **Online Theory Quiz**

Eg. If payment is made and registration is completed on 24 August, the online theory quiz is available for completion between 24 August and 28 September. The online theory quiz must be completed on the CAMS Platform within 7 days after the practical assessment

#### **Validation and Payment**

Validation by coach **AND** payment by parent must be done before the registration deadline. If payment is not made by the deadline, the registration will be invalid and booking for a new assessment date shall be made.

Parent registers for SwimSafer Stage 1 assessment on 21 September at 11:30am. Coach is notified to validate the assessment registration.

Registration deadline. Stage 1 assessment on 21 September at 11:30am closes on 31 August at 11:30am. ASSESSMENT DAY. Stage 1 assessment 21 September at 11:30am Practical assessment results. Certificate available if both the practical assessment and online theory quiz have been completed. The online theory quiz window closes 7 days after the practical assessment date. Eg. 11:30am on 28 September.



Rescheduling due to inclement weather/absence due to medical reasons

You will be notified and eligible for rescheduling of the assessment to a later date. For absence due to medical reasons, a valid medical certificate must be submitted to rescheduling.swimsafer@sgaquatics.org.sg
